## **Guaranteed Housing**



Double-check your admissions letter to see if you have 3 or 4 years of on-campus housing.

#### **First-Year Student Info**

Three Years of Guaranteed Housing?

If so, you will spend junior year living off campus. This year is non-transferable, however there is no residency requirement and students can live off campus any year.

Living off campus outside the junior year is atypical.



#### **Transfer Student Info**

Variable Guaranteed Housing

Starting Fall 2024, matriculating transfer students <u>may</u> have up to 2.5 years of guaranteed housing. Confirm your ability to live on campus next year with ResLife.

## "No More Than Four"

A group of five or more students sharing an apartment, single-family house, or any other dwelling, is a violation of the City of Boston Zoning Code.

We recommend limiting groups to four tenants.



# **Using a Rental Agent?**

At minimum, before signing you MUST...

- 1. See the unit.
- 2. Read the lease.

Using an agent? Shop around. Find one you trust. Never sign a lease under pressure.



# When to Sign a Lease

#### **First-Year Students**

Many students feel pressured to sign onto a house for junior year during their first year on campus.

#### This is NOT RECOMMENDED.

Most will sign a lease in the spring of their sophomore year after junior-year study abroad decisions have been made.

#### **Transfer Students**

You should aim to sign a lease ~3 months prior to your scheduled move-in date.

Confirm your ability to live on campus next year with ResLife before making off-campus housing arrangements.

## **Housing Database**

Logging in w/ their Agora credentials, students can...

- Review apartment listings.
- Add a sublet listing.
- Create a roommate profile.
- Access resources.

We recommend students live in apartment buildings as opposed to houses, duplexes, etc. These spaces see fewer off-campus incidents that may adversely impact the student tenants.
